



Warranty Policy

24 Month / Unlimited Mileage Limited Warranty 90 Day Replacement Parts Warranty

Allied Climate Technology warrants to the original buyer that the products manufactured by Allied Climate Technology are free of defects in material and workmanship for a period of twenty-four (24) months / unlimited mileage from in-service date. If in-service date is not registered, warranty period is defined by original installation date.

Allied Climate Technology warrants replacement parts for a period of ninety (90) days from date of purchase.

Products must be registered at www.alliedclimatetech.com within thirty (30) days of installation.

Warranty repairs require prior authorization as outlined in the Allied Climate Technology Warranty Procedure. Authorized warranty claims are paid according to the Allied Climate Technology Warranty Labor Allowances. Unauthorized warranty claims will not be paid.

Allied Climate Technology shall, at its option, repair the products or replace them with products of comparable value. In no event shall Allied Climate Technology liability under this warranty exceed the original purchase price of the products which are the subject of a proper notice of defects.

This warranty applies only within the boundaries of the United States, its territories, and Canada.
